## RULES AND REGULATIONS

1. Participant age limit: All children ages 5-15 are invited to fish. NO EXCEPTIONS!
2. Bank or shore fishing only is allowed: NO BOATS!
3. No horseplay by participants, sponsors or volunteers will be tolerated around the pond.
4. No exposed fishhooks will be allowed except at the bank. In the interest of safety, please remove hooks from lines while the rods/poles are being transported to and from the bank.
5. There is a limit of five (5) stocked fish per participant.
6. A parent, legal guardian or named responsible party must sign the release of liability from AND accompany and supervise the children during the event.
7. Participants will need to bring their own fishing gear (rods, poles, line, hooks, etc.) to the event.
8. Participants are encouraged to bring their own bait. Worms will also be provided.
